

Reviewing SEC Comment Letters on Intelligize

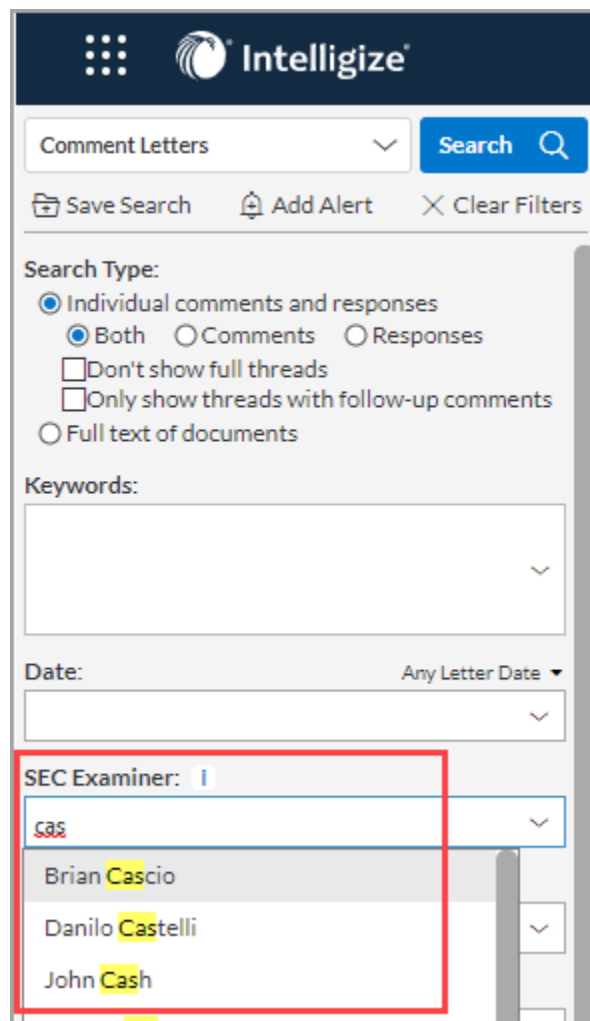
Situation: An attorney has asked that you pull SEC Comment Letters about a specific topic, company or industry code. In this instance, the attorney would like to see Comment Letters issued by Examiner John Cash that are focused in on Risk Factors.

Solution: Use the **Comment Letters** database. Intelligize’s advanced filtering allows you to drill down to specific examiners and topics with ease.

Step 1:

Click into the **Comment Letters** database. Once in the database, you will want to filter based on:

- SEC Examiner – type John Cash. You will see the auto fill narrow your choices as you type in his name.



Click **Search** and you will see all the Comment Letters John Cash has issued.

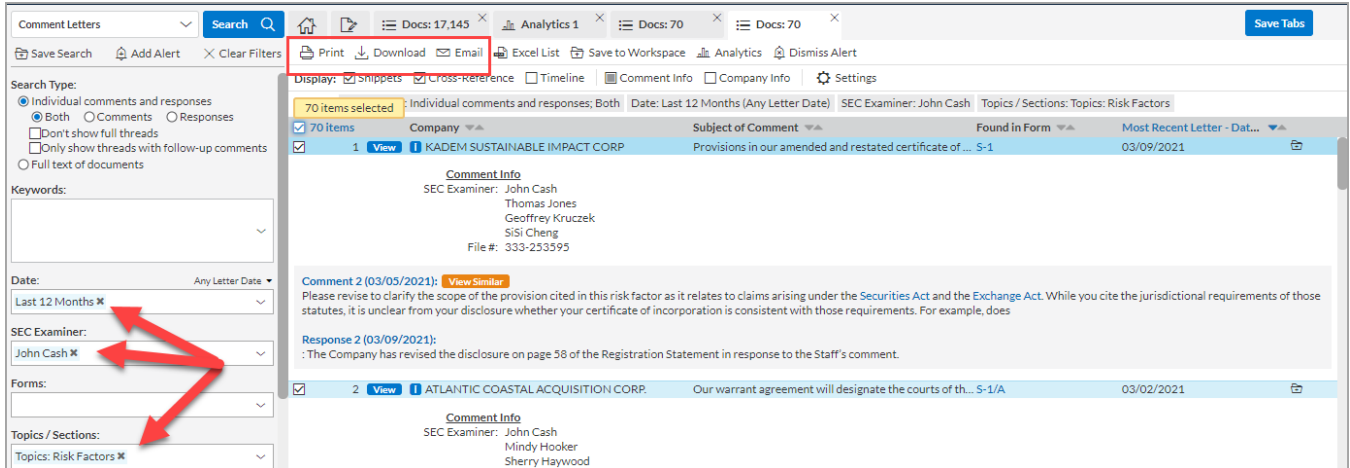

Step 3:
