Form 8-A (8-A12B/8-A12G)	Used for registration of certain classes of securities pursuant to section 12(b) or 12(g) of the Securities Exchange Act of 1934.
Form 10 (10-12B/10-12G)	 10-12B — General form for registration of securities pursuant to section 12(b) of the Securities Exchange Act of 1934 — Used for new stock issued in relation to a spin-off. 10-12G — General form for registration of securities pursuant to section 12(g) of the Securities Exchange Act of 1934.
Form 13F-HR	Quarterly Form 13F Holdings Report filed by institutional investment managers (with assets of \$100 million or more).
Form 15-12G	Certification and notice of termination of registration under section 12(g) of the Securities Exchange Act of 1934 or suspension of duty to file reports under sections 13 and 15(d) of the Securities Exchange Act of 1934.
Form 10-K	Annual report providing a comprehensive overview of the company's business and financial performance / transition report.
Form 11-K	Annual report regarding employee stock purchase, savings and similar plans.
Form 10-Q	Quarterly report providing a comprehensive overview of the company's financial performance / transition report.

Form F-1	Registration statement for securities (foreign private issuers) — Often used by a foreign private issuer launching an initial public offering (IPO).
Form F-3	Registration statement for securities (foreign private issuers).
Form F-4	Registration statement for securities of certain foreign private issuers issued in certain business combination transactions.
Form F-6	Registration statement — Used for depositary shares evidenced by American Depositary Receipts.
Form F-10	Registration statement for securities of certain Canadian issuers.
Form N-1A	Registration statement — Open-end management investment companies.
Form N-2	Registration statement — Closed-end management investment companies.
Form N-14	Registration statement — Used in business combination transactions by management investment companies and business development companies.

S-1	Registration statement — Often used by a domestic company launching an IPO.
S-1MEF	Registration statement for up to an additional 20% of securities under Rule 462(b) for any offering registered on form S-1 — MEF filings are applicable to multiple forms.
S-3	Registration statement — Simplified security registration form / short form registration statement for companies meeting eligibility requirements.
S-3ASR	Form S-3 automatic shelf registration statement — ASR filings are applicable to multiple forms.
S-4	Registration statement — Generally used in connection with mergers, acquisitions or exchange offers.
S-8	Registration statement — Used for securities to be offered to employees pursuant to certain plans.
S-11	Registration of securities of certain real estate companies.



Schedule 13E-3 (SC 13E-3)	Rule 13e-3 transaction statement — Used to report going private transactions.
Schedule 13D	Beneficial ownership report $-$ Beneficial ownership of more than five percent of a covered class of equity securities $-$ Investor with control Intent.
Schedule 13G	Beneficial ownership report — Beneficial ownership of more than five percent of a covered class of equity securities — Investor without control Intent (e.g, passive investors and qualified institutional investors).
